GENERAL RULES

- All disputes arising out of the application or interpretation of any rules or conditions of the FUTURE FORTUNES STALLION INCENTIVE Program shall be decided by FUTURE FORTUNES, Inc.
- FUTURE FORTUNES, Inc. reserves the right to alter the conditions of all or part of the Incentive fund program as it, in its sole discretion, deems necessary. FUTURE FORTUNES, Inc. may cancel the program at any time if it deems participation is insufficient to continue the program.
- For a FUTURE FORTUNES foal to be eligible for Bonus Money, the rider/owner must:
 - Designate FF horse and use horse's registered name on the producer entry form.
 - Provide a copy of horse's registration papers from a recognized breed association showing the current owner with each entry.
 - Submit a FF entry form that is on our website at each event.
 - Each owner must have a current W9 on file with Future Fortunes before checks are mailed.
 - Foreign entries must have a W-8 BEN on file with Future Fortunes before checks are mailed.
- Each Participant in FUTURE FORTUNES Stallion Incentive Program covenants and agrees that he/she will not at any time, through any medium, either orally or in writing engage in prohibited communications—including but not limited to email, Facebook and other social media, internet forums, blogs, or television or radio—disparage, defame, impugn, damage or assail the reputation, or cause or tend to cause the recipient of a communication to question the integrity, competence, good character, or professionalism, of FUTURE FORTUNES, Inc., provided that nothing shall prohibit a Participant from communicating truthfully to such Participant's legal counsel or as otherwise required by law or order of court. If Participant or any other agent of Participant engages in prohibited communications, as above, such Participant is ineligible to receive any stallion incentive bonus money for the remainder of the year from the date FUTURE FORTUNES, Inc. is notified of the infraction or for 6 months whichever is greater and is further subject to ¶15 of these General Rules.
- In the event of any action or proceeding to declare or enforce FUTURE FORTUNES, Inc. rules, FUTURE FORTUNES, Inc. rights and/or participant covenants and duties under these Rules, FUTURE FORTUNES, Inc. shall be entitled to recover its reasonable attorney's fee and other costs, in addition to any other relief that may be granted and such action(s) will be brought under the laws of Oklahoma in the District Court of Cleveland County, Oklahoma and any federal court with concurrent jurisdiction.

Dash and Dance RULES

FORMAT	The Dash and Dance Futurity will be 2 Go-rounds and an average. Total time of the 2 rounds will determine the Championship standing. Futurity time can be rolled to the Open 4D to follow.	
ELIGIBILITY	The Dash and Dance Barrel Futurity is open to horses that are 5 years old or younger. Horses must have not reached the age of six by the time of the futurity.	To be eligible for the Futurity, the horse must never have competed in any barrel race, including AQHA shows, playdays, derbys, rodeos, etc. prior to November 15, 2021. To do so means forfeit of any and all fees paid and elimination from the futurity. Horses may have competed anywhere after Nov 15, 2021. Horses may have been entered in other events.
	A photocopy of the front and back of registration papers of registered horse or veterinarian's affidavit of year of birth and complete physical description of the unregistered horse must accompany nominations. Entry will be considered late if this information does not accompany entry form.

BUYOUTS	Buyouts allowed until 10 am on July 19 th with a \$60 Office Fee. All paperwork and buyout fee must be received in office by 10 am on Tuesday, July 19 th to be considered complete.	Buyouts are only allowed for fully paid in entries. SL Productions is not responsible for payment between buyer and seller.
RIDER CHANGE:	Rider changes allowed through the end of check-in. A fee of \$30 will be assessed after July 1 st . It is the owner's/rider's responsibility to be sure that the office has the correct rider listed. Horses must be ridden by the same rider throughout the event, however SL Productions has the right to make exceptions to this rule when deemed necessary.	Should nominated horse be sold during the payment period, written authorization must be received from the original owner before the horse can continue to be paid on.
SUBSTITUTIONS	Substitutions are allowed only due to injury/death of nominated horse. A veterinarian's affidavit of proof must accompany substitution paperwork along with a \$30.00 fee. Substitutions can only be made by the same rider and/or owner of the originally nominated horse.	
CHECK IN	All futurity horses must be checked-in and numbered to run. Check in options will be Wednesday 2-5 pm, Thursday from 10:00 am–12:30 pm, or 3:00–4:30 pm or Friday from 7:30–8:30 am.	
FUTURITY EXHIBITIONS	All futurity horses MUST BE CHECKED-IN AND NUMBERED to use their 2 futurity exhibitions. Both futurity exhibitions will be run together on Thursday, July 22 from 1:00-4:00pm! Horses must be numbered. Futurity Exhibitions will be run in draw order and both exhibitions will be run back to back together ONLY ONE TIME THROUGH DRAW ORDER-NO EXCEPTIONS	
PAYBACK	Payout is \$210 of each entry and 100% of the added money.	\$8,000 guaranteed added to event.
